#### VI. Reports

The Manager stated he had given Council two handouts. One is a draft disc golf course layout for Mt. McSauba. The draft will be going to the Recreation Advisory Board for a meeting Friday, May 20 at 6:30 p.m. for input and discussion and will hopefully come to the Council at the June 6 meeting. There will be a related article in the Charlevoix Courier requesting public input on the course. The second handout is an update from DDA Director Keith Carey on the Up North Fourth event.

The Manager thanked MDC for the work they donated on the petunia beds.

The Clerk presented Council with information regarding a Freedom of Information Act and Open Meetings Act class in Gladwin. Council members should contact her if they would like to attend.

#### A. Consideration to Install a Peace Pole in Bridge Park

Junior Girl Scouts Rachel Nesburg and Alexandria Snabes presented Council with their proposal to install a peace pole in Bridge Park for their Bronze Project. Leader Maura Snabes was available to assist the scouts in answering questions from Council.

# DeWitt Parking Lot

Police Chief Gerard Doan reviewed his recommendation to leave the DeWitt lot as a free parking lot. The Chief compared the lot to spots that are seasonally rented in the Acacia lot, which were not being used. Staff's opinion is that the lot is used by downtown workers, freeing up lots on Bridge Street for turnover shopper parking. Council discussed at length, with some members expressing concern that the lot would take funds to maintain, competes with other privately-owned rental spaces, and was a possible missed source of revenue. The Mayor relayed the DDA members' opinions that the lot should remain a free lot to encourage workers to park off of Bridge Street.

During audience comment, Bob Timms stated that the City should generate a few thousand dollars out of the DeWitt parking lot. The lot isn't free to the City and must be maintained.

Council continued to discuss and eventually directed Staff to gather information regarding the cost of installing a meter system and present options at a special meeting.

# C. Consideration to Approve Element 1 of the Childs Consulting Associates Proposal

John Childs from Childs Consulting Associates reviewed the proposal regarding the possible uses of excess fiber optic bandwidth owned jointly by the City and School District. The School Board has already approved this phase of the proposal. The City's cost is \$1,000 on this phase.

#### G. Consideration to Approve Bid for Meech Street Infrastructure Project

Project Engineer Jim Malewitz from Performance Engineering was available to review the item and answer questions from Council. Mr. Malewitz and Staff recommend awarding the bid to MDC Contracting, as they are a local bidder and fall within the percentage allowable under the City's Local Bidder's Preference policy; the difference between the low bid and MDC's is 1.19%.

Motion by Councilmember Dennis Kusina, seconded by Councilmember Jill Picha, to award the bid to MDC Contracting, if they will match J&N's construction price.

Attorney Bryan Graham informed Council that they could not make such a request of a bidder; they can review all the bids, but they have to accept a bid as proposed. They cannot place a condition that the local bidders match the low bidder.
