V. Public Hearings

A. Budget Amendment for the 2009-10 Budget Ordinance

City Treasurer Rick Brandi reviewed the item for Council. This is bookkeeping to keep the City in compliance with Public Act 202. It is the best estimate of where the City will end up at end of fiscal year, March 31, 2010. The Mayor opened the public hearing at 7:03 p.m. There were no comments. The Mayor closed the public hearing at 7:03 p.m.

B. 2010-11 Budget Ordinance

City Treasurer Rick Brandi stated that this public hearing is also the truth in taxation hearing for the year. The budget proposes no changes in our millage rates. The millage rates are based on draft estimates for taxable values; we'll know what those values are by May 29. Additionally, the fire and EMS contracts are not settled. The general fund budget has been reduced by about five percent. Three lifeguards have been added back in for one of the beaches, with the funds being reduced elsewhere from the recreation budget portion of the general fund. The Downtown Development Authority has also reduced their budget by \$6,100. The rates will be adopted by resolution, rather than ordinance to make changes during the year easier if needed. The budget figures are based on current revenues and staffing levels. The Mayor opened the public hearing at 7:07 p.m.

Marybeth McGraw, representing the Charlevoix Waterfront Art Fair, asked for and received clarification regarding proposed charges for services at events. The Mayor stated that the City was trying to be reimbursed for expenses such as port-a-johns and trash pickup. The City is not planning on charging rental fees for festival locations.

Bob Timms stated he thinks the police force needs the summer help that has been eliminated from the budget. He suggests eliminating a full time officer that is not needed in the winter and getting part time officers for the summer when they're needed. The Mayor stated that the police force will probably be revisited throughout the year. Mr. Timms also questioned the need for a new street sweeper and sweeping the streets without curbs. Mr. Timms also suggested cutting the fire department dive team expenses and reducing the Police Department secretary from full to part time.

The Mayor closed the public hearing closed 7:13 p.m.

VI. Reports

The Manager stated he has been attending the broadband meetings with Merit Corporation, recipient of the \$42 million federal stimulus grant. Merit is proposing to expand broadband throughout the state, especially to rural areas. According to the current plans, the broadband dead-ends on the north and south ends of town, providing no coverage in the City. Coverage through the City is needed. Merit had thought since the City had partnered with the school district and has fiber optics throughout the community, they could connect to that fiber to serve the community. The Manager stated there are limited amount of fiber strands and are security issues with having businesses connecting to the City's fiber optic. The Manager is making the argument that Merit needs to close that gap and connect the north and south sides. He is working with Chamber of Commerce Director Erin Bemis to help get this resolved, as it is also an economic development issue.

VII. Requests, Petitions and Communications and Actions Thereon

A. Discussion Regarding Fire/EMS Discussions with Local Townships

The Manager provided an update on the discussions with the surrounding townships for fire and EMS services. Staff is proposing going back to the townships with a fee reduction based on reducing full time employees from four to three and see which townships are interested in contracting with the City. Council does not need to make a decision regarding staffing at this point. The Manager would like the present the proposals to the townships and give them a month to review with their boards and get back to the City. Once the City knows who is interested, we can either offset the costs of the fourth firefighter or reduce the staff at that time. Council members spoke in favor of retaining the fourth firefighter and discussed the possibility of being able to retain the position, either by supplementing the cost if the townships agree to use our services, or possibly by eliminating surplus equipment of the townships if they do not contract with us. Council generally agreed to staff's proposal to present the reduced fee proposal to the townships.

B. Discussion Regarding Grant Options for Urban Revitalization Grant through the Michigan Economic Development Corporation

The Manager presented the item. Staff recommends the Clinton Street Project of water line replacement, stormwater improvements and new street asphalt as being the best candidate for the grant. Staff proposes making the grant more competitive by choosing to match grant dollars on a 60-40 percent basis. Council generally agreed for staff to apply for the grant per staff's recommendations.

C. Consideration to Approve \$50,000 Grant Agreement with the Department of Energy, Labor and Economic Growth

The Manager stated the City had received a \$50,000 grant from the Department of Energy, Labor, and Economic Growth for energy efficiency improvements. The City estimates approximately \$13,000 per year energy cost saving upon completion of the improvements.

Motion by Councilmember Greg Stevens, seconded by Councilmember Shane Cole, to authorize the City Manager to sign grant documents for a \$50,000 grant through the Department of Energy, Labor, and Economic Growth.

2010-2011 BUDGET APPROPRIATION ACT**

THE CITY OF CHARLEVOIX ORDAINS:

WHEREAS, The City Council of the City of Charlevoix did give notice of the time and place when a public hearing would be held in conformity with provisions of Section 7.8, Article VII of the City Charter, which Public Hearing was duly held pursuant to said notice and in conformity therewith;

THEREFORE, BE IT RESOLVED, That the revenues and expenditures for the fiscal year commencing on April 1, 2010 and ending March 31, 2011 are hereby appropriated on an activity level basis (a detailed breakdown by detail level can be found in the Budget Details document) as summarized by the following:

BE IT FURTHER RESOLVED, That the City Council of the City of Charlevoix does hereby levy a tax of 11.1528 mills (9.05 mills operating and 2.1028 mills infrastructure) for the period of April 1, 2010 through March 31, 2011 on all real and personal property in the City of Charlevoix according to the valuation of the same. This tax is levied for the purpose of defraying the general expense and liability of the City of Charlevoix and for infrastructure improvements, and is levied pursuant to Section 8.1, Article VIII of the City Charter; and

BE IT FURTHER RESOLVED, That the City Council does hereby levy a tax not to exceed 1.3631 mills for the period April 1, 2010 through March 31, 2011 on all real and personal property in the Downtown Development District, according to the valuation of the same within the district; and

BE IT FURTHER RESOLVED, That the City Council does hereby levy a tax not to exceed 1 mill for the period April 1, 2010 through March 31, 2011 on all real and personal property in the City of Charlevoix, according to the valuation of the same. This tax is levied for the purpose of defraying the cost of rubbish collection and other related services provided citizens allowed by the act, and is levied pursuant to Michigan Public Act 213 of 1969; and

BE IT FURTHER RESOLVED, That the City Council does hereby approve the following budgets for the period April 1, 2010 through March 31, 2011 in the amounts set forth below by fund:
